- 1. A covering letter for Renewal Membership.

- 3. Pay Order for Rs. 8,000/- in favour of PHMA.
- 4. Proof of filing of return of Income Tax (U/S 115) for the preceding year (2015) with acknowledgement.
- 5. Copy of valid CNIC of the authorized representative (if expired during the year or didn't submit last year)
- 6. Copy of last Membership Certificate of PHMA (Valid upto 31-03-2016).
- 7. Copy of last Membership Certificate of the Chamber (KCCI) (if registered).
