S.R.O.1055(I)/2015.- In exercise of the powers conferred by sub-section (3) of section 18 of the Customs Act,1969 (IV of 1969), the Federal Government is pleased to direct that the following further amendments shall be made in its Notification No. S.R.O.568(I)/2014, dated the 26th June, 2014, namely:-

In the aforesaid Notification, in the Table, in column (1),-

- (i) after S.No.197C and the entries relating thereto in column (2), (3) and (4), the following new serial numbers and the entries relating thereto shall be inserted, namely:-

- (d) imports under the Baggage Rules,2006;
- (e) imports under sub chapters 3 and 7 of chapter XII and chapter XV of Customs Rules, 2001;
- (f) imports under Small and Medium Enterprises and Export Oriented Units Rules, 2008; and
- (g) imports under Temporary Importation Scheme vide S.R.O. 492(I)/2009, dated the 13th June, 2009.
