SUBJECT: **SECOND PAKISTAN-BELARUS FORUM ON TEXTILE**

Last year, Pakistani delegation of leading exporters headed by the Secretary, Textile Division visited Minsk, Belarus in 40<sup>th</sup> International Specialized Exhibition-Fair of Textile, Apparel and Footwear Goods "BELTEXLEGPROM Spring 2017" and 1<sup>ST</sup> Pakistani-Belarusian textile forum.

2. This year the Second Belarus-Pakistan Textile Forum on the margins of the International Exhibition and Fair on wholesale trade of light industry goods "BelTexindustry-2018" is scheduled to be held on 28-30 March, 2018 in Minsk, Belarus.

3. It is pertinent to mention that Trade Development Authority of Pakistan (TDAP) has decided on representation from public & private sector with the following composition;

- i. **01 Officer from Textile Division**
- ii. **01 Officer from Commerce Division**

4. Under the policy, TDAP will provide the following financial provision/subsidy for 03days only to the private members belonging to the textile sector and Pharmaceutical sector;-

"50% of the return economy airfare on the shortest route to and from the destination/destinations of the delegation and US\$ 100 per day per delegate"

5. Keeping in view of above it is proposed that nomination for the said forum may be furnished to this Division **latest by, 15<sup>th</sup> March, 2018**, positively.
