ANNOUNCEMENT OF ELECTION SCHEDULE AND INVITATION OF NOMINATIONS FOR THE EXECUTIVE COMMITTEE

Approved Election Schedule for 2024-2026 is enclosed. As such, Elections shall be held to fill the 14 Seats from each Zones (Total 28-seats).

ELIGIBILITY TO VOTE & ELECTORAL COLLEGE

As per Rule 21(c) of the TO Rules 2013, the electoral college for the Executive Committee shall be members of General Body.

As per Rule 15 of Trade Organizations Rules 2013 and Articles of Association, the eligibility of a member of PHMA to vote at the elections shall be subject to following conditions:

- a) The member has completed two years of valid membership of PHMA as on the date of announcement of Election Schedule by the Executive Committee:

Provided that old members shall be eligible to vote on completion of one year of their re-enrollment and payment of all dues; and

- b) The member has fulfilled the conditions of membership and renewal thereof under Rule 11 of the Trade Organizations Rules-2013.

As per Rule 15(2) of TO Rules 2013, every member eligible to vote shall deposit with the Secretary General or concerned Zonal Secretary, the Specimen Signature Card along with photograph indicating the status in the firm, company or concern. The right to vote shall be allowed only to the Proprietor, Partner or the Director of the member firm or company, or a person not below the rank of General Manager authorized by the Board of Directors of a public limited company or a multi-national corporation, as the case may be.

As per Rule 15(3) of TO Rules 2013, The Proprietor, Partner or Director of the member firm or company, concern or a person not below the rank of General Manager authorized by the Board of Directors of public limited company or a multinational company shall be entitled to cast vote at the time of election only if name of such person has already been registered with the Secretary General or concerned Secretary and his name appears on the list of voters.

NOMINATIONS

- (1) Every member having no outstanding dues in the Association is entitled to file Nomination(s) on the vacant seats of Executive Committee and Zonal Committee.
- (2) Nomination paper should be enclosed in a plain and sealed envelope.
- (3) Nomination Papers shall be available with the Central & Zonal Offices of the Association and can be obtained during office hours on the dates mentioned in the election schedule, duly signed and stamped by Secretary General/ Zonal Secretaries.
- (4) Nomination(s) should be submitted in-person into the “**Nomination Box**” specially provided for the purpose, at the PHMA Central Office & Southern Zone at Karachi, Northern Zone at Lahore during office hours on the dates mentioned in the schedule.

- (5) Nomination papers received by post shall not be considered for the purpose of the elections.

Within the period mentioned in the Election Schedule of the issuance of the final list of voters, any person who is eligible to contest the election for the vacant seat of Executive Committee, shall send his nomination duly proposed, seconded and signed by the candidate to the Secretary General / Zonal Secretaries on the prescribed form in accordance with the Trade Organization Rules 2013 and Articles of Association of PHMA.
