- 12) **To keep close liaison with the Trade Development Authority of Pakistan** and join hands in its efforts for boosting knitwear exports.

- 17) To make efforts and **ensure release of all pending DLTL / DDT Claims of exporters** to ease the severest ever liquidity crunch being faced by the exporters.
- 18) To make efforts for **Release of payment of Customs Rebate Claims of exporters on "first-cum-first-served basis"** so that no injustice is done in this regard.
- 19) To make efforts for **Release of payment of Sales Tax Refund Claims of exporters on "first-cum-first-served basis"**.
- 20) To make efforts to convince the government to **pay refunds to the exporters at the time of exports proceeds realization** to save precious time of FBR and the exporters.
